### 4. Paying the Category Charges

- a. Rs. 5,750/-(inclusive taxes) will be charged from the Local Suppliers for each category.
- b. US \$ 15 will be charged from the Foreign Suppliers (in the case of unavailability of a Local Agent) for each Category.
- c. The payments for the Registration of Local Suppliers for the year 2023 can paid to the Accountant at Sri Lanka Cricket, No.35, Maitland Place, Colombo 7 with written Company request by cash or by way of a pay order/bank draft issued in favour of "Sri Lanka Cricket" or direct payment to the *Bank of Ceylon A/C No. 8353087, Torrington Branch*. The cash deposit slip should be attached to the application form. The pay order/Bank draft should be valid at least for 90 days. Money orders will not be accepted. The payment also can be transferred by *online* to the above A/C No. and for verification purpose a clear image of the screen shot should be attached to the application form.
- d. Foreign Suppliers should use the Swift Code to credit the payments to the Bank of Ceylon instead of above. SWIFT No "BCEYLKLX"

- e. The Cash deposit Slip which utilized for the payments with the category charges should be forwarded together with the application. (As a certification to the payments made over the category charges)
- f. Both Local and Foreign Suppliers should complete the payments over the category charges during the period from 10<sup>th</sup> Oct. 2022 to 30<sup>th</sup> Nov. 2022 Sri Lanka Cricket will not be responsible for the payments made after 30<sup>th</sup> Nov. 2022 and not be considered for registration.
