

REGISTRATION OF SUPPLIERS/ CONTRACTORS FOR THE YEAR - 2024



1. Applications are hereby invited by the Chief Executive Officer, Sri Lanka Cricket from Foreign manufacturers and authorized Agents of Manufacturers, Local Manufacturers, Service Providers, Suppliers, Civil Engineering Contractors and Consultants who wish to register themselves with the Sri Lanka Cricket for the supply of goods and services for the year 2024.

2. Obtaining the Applications

a. Local Suppliers

Applications can be obtained from the Administration Department, Sri Lanka Cricket, No. 35, Maitland Place, Colombo 7 or could be downloaded from www.srilankacricket.lk

b. Foreign Suppliers

The application forms can be downloaded from www.srilankacricket.lk

A set of application forms will consist of following components.

- (1.) Main Application Form. (2.) General Instructions, terms and conditions. (3.) The detailed category list.

4. Paying the Category Charges

- Rs. 6 000/- + applicable taxes will be charged from the Local Suppliers for each category.
- US \$ 20 will be charged from the Foreign Suppliers (in the case of unavailability of a Local Agent) for each Category.
- The payments for the Registration of Local Suppliers for the year 2024, can be paid to the Accountant at Sri Lanka Cricket, No.35, Maitland Place, Colombo 7 with written Company request by cash or by way of a pay order/bank draft issued in favour of "Sri Lanka Cricket" or direct payment to the **Bank of Ceylon A/C No. 8953087, Torrington Branch**. The cash deposit slip should be attached to the application form. The pay order/Bank draft should be valid at least for 90 days. Money orders will not be accepted. The payment also can be transferred by **online** to the above A/C No. and for verification purpose a clear image of the screen shot should be attached to the application form.
- Foreign Suppliers should use the Swift Code to credit the payments to the Bank of Ceylon instead of above.

- The Cash deposit Slip which utilized for the payments with the category charges should be forwarded together with the application. (As a certification to the payments made over the category charges)
- Both Local and Foreign Suppliers should complete the payments over the category charges during the period from 15th Oct. 2023 to 30th Nov. 2023 Sri Lanka Cricket will not be responsible for the payments made after 30th Nov. 2023 and not be considered for registration.

5. Duly completed application forms together with all the requested documents should be sent by registered post to: **Head of Administration, Sri Lanka Cricket, No.35, Maitland Place, Colombo 7 On or before 30th Nov. 2023**. The top-left hand corner of the envelope containing the application in respect of Local Suppliers should be marked as "REGISTRATION OF SUPPLIERS - 2024 (LOCAL)" and Foreign Suppliers marked as "REGISTRATION OF SUPPLIERS - 2024 (FOREIGN)".

6. Authority to take final decisions regarding the Registration of Suppliers for the year 2024 is vested with the Sri Lanka Cricket.
